## Terms and Conditions – Waterside Credit Union – Christmas Prize Draw

The prize draw will run from 1.00pm on 01/12/2020 until 2.30pm on 12/12/2020 inclusive. Entry to the prize draw is free and no purchase is necessary.

One winner only (per prize) will be drawn at random from all eligible entries received (the Valid Entry). The prize draw will take place on Tuesday, 15th December 2020 by an independent person witnessed by the Organisers, and Manager. The Organisers are Waterside Credit Union.

The winners' details will be posted on the Waterside Credit Union website and Facebook page to make everyone aware that the winners have been announced.

A Valid Entry is defined as one which has completed all the required steps, i.e. 'Like' the Waterside Credit Union Facebook page like the post 'Waterside Credit Union Christmas 2020 Prize Draw' and comment 'Win'.

Entry will also be accepted by completing the form, 'Waterside Credit Union Christmas 2020 Prize Draw', available in the Waterside Credit Union office.

There is only one "Valid Entry" per person allowed. We will ensure all entries are recorded and verified. We will ensure everyone who has entered has been checked twice, adhered to the conditions and their names recorded on our IT systems.

The prize is £50.00. The prize is as described. The prize is non-transferable. The winners will be notified by telephone.

Winners must be available to collect prize by **19<sup>th</sup> December 2020**. All extra expenses incurred by the winner are their own responsibility.

If the prize is declined or unclaimed for whatever reasons after 5 working days from notification the prize will no longer be available to that person without any liability to Waterside Credit Union. Your statutory rights are not affected.

Unless you have specifically requested to receive further information from Waterside Credit Union your personal details will only be used by Waterside Credit Union for the purposes of administering this prize draw and will be destroyed afterwards.

If there is any reason to believe that there has been a breach of these terms and conditions, Waterside Credit Union may, at its sole discretion, reserve the right to exclude you from participating in the competition.
